

Terms of Service

Last Modified: June 14, 2023

These Terms of Service, including any policies, rules and other documents that are expressly incorporated herein by reference (collectively, the "Terms"), sets forth a legally binding agreement between you and HealthOK, Inc ("HealthOK", "we", or "us"). These Terms govern your access to and use of any HealthOK websites, applications, software, products and services that link to these Terms, including the HealthOK mobile application (the "App") and the website located at [healthokglobal.com] (the "Site"), and any content, information, features, capabilities, functionality, products and services offered on or through the App and the Site (collectively, the "Services"), whether as a guest or a registered user. Please read these Terms carefully before accessing or using the Site or any Services.

ARBITRATION NOTICE: THESE TERMS CONTAIN A BINDING ARBITRATION CLAUSE (SECTION 22) AND CLASS ACTION WAIVER (SECTION 23) THAT WAIVE YOUR RIGHT TO A COURT HEARING AND JURY TRIAL. PLEASE READ THEM CAREFULLY.

1. Acceptance of Terms

By using any of the Services (whether or not you have an HealthOK account or Subscription (as defined below) to any particular Services), or by clicking to accept or agree to these Terms when this option is made available to you, you accept and agree to be bound by these Terms and to abide by all applicable laws with regard to your use of the Services. Except as specified herein, these Terms apply to any use of the Services, including, without limitation, when you: (i) interact with us on or through the App and/or the Site; or (ii) create and use a free HealthOK account. In order to use the Services, you must first agree to these Terms. If you do not agree to be bound by these Terms and to abide by all applicable laws, you may not use any of the Services. In addition to these Terms, your use of certain Services may require you to accept additional terms and conditions applicable to such Services, including any additional terms and conditions applicable to Subscriptions (collectively, "Additional Terms"). When using particular Services, you shall be subject to any rules or policies applicable to such Services that may be posted or made available to you through the Services from time to time ("HealthOK Policies"). The Additional Terms and HealthOK Policies are incorporated and made a part of these Terms by this reference.

2. Changes to Terms

HealthOK reserves the right, at its sole discretion, to change, modify, update or supplement these Terms or any Additional Terms that apply to a Service, at any time, including to reflect changes to the law or changes to our Services. When these changes are made, HealthOK will make a new copy of these Terms available on the App and the Site, and any Additional Terms will be made available to you from within, or through, the affected Services. All changes are effective immediately when we post them or make them available to you, and apply to all access to and use of the Services thereafter. You acknowledge and agree that if you use the Services after the date on which these Terms have changed, HealthOK will treat your use as acceptance of the updated Terms. It is your responsibility to check these Terms periodically for changes. Your continued use of the Services following the posting of any changes will mean that you accept and agree to the changes. If any changes are unacceptable to you, you may stop using the Services and, if applicable, cancel your Subscription.

3. Privacy Statement

When you access the App or the Site or use any of the Services, you provide us with different types of information. Please read our [Privacy Statement](#) which explains how we collect, use and share information through the App, the Site and the Services, as well as your choices regarding these activities. The Privacy Statement applies to use of the App, the Site and the Services, and its terms and conditions are hereby incorporated into and made a part of these Terms by this reference.

4. Eligibility to Use the Services

The Services are intended for adults in the countries where they are being offered. You may not use the Services if you are (i) not of legal age to form a binding contract with HealthOK or (ii) barred from receiving or using the Services under the laws of the jurisdiction in which you are resident or from which you use the Services. By using the Services,

you represent that you satisfy the requirements set forth herein. You must be at least 18 years of age to purchase or use any Services.

5. Account Creation

You may need to create an HealthOK account in order to access and use the Services. To protect your HealthOK account, please keep your username and password strictly confidential. You are solely responsible for maintaining the confidentiality of your username, password and other account information, and are fully responsible for all activities performed through use under your HealthOK account. If required, you will create a username and password for your HealthOK account. You must provide accurate, complete and current registration information when you register and create an HealthOK account. In consideration of your use of the Services, you agree to: (i) provide true, accurate, current, and complete registration information about yourself as prompted by the Service; and (ii) maintain and promptly update the registration information to keep it true, accurate, current and complete. If you provide any registration information that is untrue, inaccurate, not current or incomplete, HealthOK has the right to limit, suspend or terminate your account and your access to the Services (or any portion thereof). You agree to immediately notify HealthOK of any unauthorized use of your HealthOK account and ensure that you exit from your account at the end of each session. HealthOK will not be liable for any damages arising from your failure to comply with this Section.

6. Subscriptions

You may purchase access to certain Services and HealthOK Content on a subscription basis ("Subscriptions"). Subscriptions automatically renew as set forth below until cancelled in the subscription settings section of your HealthOK account page. We will notify you if the price of a Subscription increases and, if required, seek your consent to continue. You will be charged no more than twenty-four (24) hours prior to the start of the latest Subscription period. If we cannot charge your payment method for any reason (such as expiration or insufficient funds), and you have not cancelled the Subscription, you remain responsible for any uncollected amounts, and we will attempt to charge the payment method as you may update your payment method information. This may result in a change to the start of your next Subscription period and may change the date on which you are billed for each period. HealthOK reserves the right to cancel your Subscription if we are unable to successfully charge your payment method to renew your Subscription. When your Subscription ends, you will lose access to the Services and HealthOK Content that require a Subscription.

Prices and Refunds

For Subscriptions, you will be charged the rate stated at the time of purchase (plus applicable taxes) at the beginning of each billing period of your Subscription via the payment method that you have provided to HealthOK. You are solely responsible for ensuring that your billing and payment information is correct to prevent your Subscription from being cancelled.

Prices and terms for Subscriptions may change at any time. The prices and terms in effect as of the Subscription Start Date or the date your Subscription last renewed (as applicable) shall remain in effect for the duration of the applicable Initial Subscription Period or Renewal Subscription Period (as the case may be), provided that new or modified prices and terms may apply to renewals or new Subscriptions. HealthOK will provide you with reasonable notice of any updates or changes in prices or terms before they become effective. If you do not want to renew your Subscription under such new or modified prices or terms, you may cancel your Subscription as described herein.

All refunds of any pre-paid Subscription fees that you may be entitled to receive pursuant to these Terms will be credited to the then current payment method associated with your HealthOK account. Refunds are not based on account usage. If you terminate your Subscription and HealthOK account for HealthOK's material breach of these Terms after providing HealthOK with a forty-five (45) day cure period during which time HealthOK fails or is otherwise unable to cure such material breach, HealthOK will refund to you any pre-paid Subscription fees on a pro-rated basis.

Initial Subscription Period

Once your initial Subscription payment is processed, effective as of that date (the "Subscription Start Date"), your Subscription shall immediately commence, and you can access the applicable Services and HealthOK Content. Your Subscription shall commence on your Subscription Start Date and continue to be effective for an initial period of twelve (12) months following your Subscription Start Date (the "Initial Subscription Period"). If you are a first-time

Subscriber to HealthOK, you may cancel your Subscription after 3 months after your Initial Subscription Period for a full refund. If you are not a first-time Subscriber or if you cancel your Subscription after 3 months of your Initial Subscription Period, you will not receive a refund of any kind or for any amount, but you shall continue to retain access to the applicable Services and HealthOK Content for the remainder of your Initial Subscription Period, after which your Subscription will be cancelled.

Automatic Renewal of Subscription

If you do not cancel your Subscription within your Initial Subscription Period and you elected monthly billing upon initial Subscription, then your Subscription shall renew automatically for additional, successive one (1) month periods (each, a "**Monthly Renewal Subscription Period**"), and your Subscription shall continue on a month-to-month basis as described herein until cancelled in accordance with these Terms. During any Renewal Subscription Period, you may cancel your Subscription at any time prior to the five (5) day period before the next Subscription renewal date, provided that you shall not be entitled to nor receive a refund of any kind or for any amount. If you cancel your Subscription at any time during a Renewal Subscription Period, you shall continue to retain access to the applicable Services and HealthOK Content for the remainder of the then-current Renewal Subscription Period. If you cancel your Subscription at any time within the five (5) day period before the next Subscription renewal date, your Subscription shall renew automatically for one (1) additional Renewal Subscription Period, after which your Subscription will be cancelled.

If you do not cancel your Subscription within your Initial Subscription Period and you elected annual billing upon initial Subscription, then your Subscription shall renew automatically for additional, successive one (1) year periods (each, an "**Annual Renewal Subscription Period**"), and your Subscription shall continue on an annual basis as described herein until cancelled in accordance with these Terms.

7. Description of the Services

The Services include access to certain portions of the Site and certain proprietary services, and certain Services may only be accessible or used via the App. Unless explicitly stated otherwise, each new feature that augments or enhances the current Service shall be subject to these Terms. You acknowledge and agree that the Services are provided "AS-IS" and are based on the current state of the medical affairs in practice at the time of purchasing the Services. You acknowledge and agree that the form and nature of the Services which HealthOK provides may change from time to time without prior notice to you, and that HealthOK may stop (permanently or temporarily) providing certain Services (or any features within the Services) to you or to users generally at HealthOK's sole discretion, without prior notice to you. You may stop using the Services at any time. You do not need to specifically inform HealthOK when you stop using the Services unless you are requesting closure of your account. HealthOK assumes no responsibility for the use of Services in any manner not contemplated by these Terms, or any use of the Services in violation of these Terms.

In order to use the Services, you must obtain Internet access, either directly or through devices that access web-based content, and pay any service fees associated with such access. You are solely responsible for paying such service fees and obtaining all equipment necessary to make such Internet connection, including a computer and modem or other access device. You are solely responsible for providing such equipment. HealthOK is not responsible for the payment of any medical fees or co-pays associated with some of the Services.

8. The HealthOK Mobile Application

License Grant

Subject to these Terms and your compliance with these Terms, HealthOK grants to you a limited, personal, non-transferable, non-assignable, non-sublicensable, non-exclusive, terminable and revocable license to: (i) download and install the App on a single personal mobile device owned or controlled by you (or, if you downloaded the App from the Apple App Store, on any Apple-branded product running the iOS operating system that you own or control); and (ii) access and use the App as described in these Terms solely for your own personal, non-commercial purposes in accordance with these Terms and the HealthOK Policies. No license is granted to any third party and you have no right to make available to anyone access to the App or the Services. Except as otherwise provided in these Terms, you have no right or license to use the App or Services for the benefit of another. You do not have any rights beyond what is granted to you in these Terms. HealthOK reserves all rights not expressly granted to you in these Terms.

Consent to Collection and Use of Technical Data

By accessing and using the App, you expressly acknowledge and agree that HealthOK may collect and use technical data including, without limitation, data concerning your mobile device, application software and peripherals to facilitate the provision of updates and other support to you, and for product improvement and quality assurance purposes. Any collection and use of such technical data is governed by our Privacy Statement.

Errors, Bugs and Updates

You acknowledge that the App is provided on an “AS IS” basis and may contain errors. HealthOK does not and will not give any warranty or guarantee regarding the App or whether the App will be available or operate without error. HealthOK will not be liable if, for any reason, all or any part of the App is unavailable. HealthOK does not guarantee uninterrupted access to the App or availability of the App. You acknowledge that your access to the App may be interrupted for scheduled or emergency maintenance purposes, to fix bugs, for security, or other reasons. Access to the App may also be interrupted for reasons outside of HealthOK's reasonable control. You acknowledge that the App and any information made available via the App may contain errors, including typographical errors, inaccuracies, and omissions. HealthOK reserves the right to, at any time without notice, correct any such errors, inaccuracies, or omissions, and to change or update any information offered on or through the App.

You acknowledge that the App has not been developed to meet your individual requirements and that it is therefore your responsibility to ensure that the App as described on the applicable app storefront and in these Terms meets your requirements. You acknowledge that internet transmissions are never completely private or secure. HealthOK cannot guarantee the confidentiality or integrity of any documents, reports, materials, content, information or data sent or received via the App. This means that any document, message, information, and data you send using the App may be read or intercepted by others, even if there is a special notice that a particular transmission is encrypted.

Updates to the App

From time to time HealthOK may make updates available to you to improve the App's performance, to fix bugs or provide patches, to address security issues, to enhance, add or remove features or functionality, and/or to improve the user experience or make alterations to functionalities, with or without notice to you. HealthOK may require certain updates for continued use of the App on your mobile device to address security threats. HealthOK reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, the App (or any part thereof) with or without notice. We undertake no obligation to update, amend, or clarify information on the App, except as otherwise provided herein or required by applicable law. No specified update or refresh date applied on the App should be taken to indicate that all information on the App has been modified or updated.

Based on your mobile device settings, when device is connected to the Internet either: (i) the App will automatically download and install all available updates; or (ii) you may receive notice of or be prompted to download and install available updates. You must promptly download and install all updates when made available to you and you hereby acknowledge and agree that the App or portions thereof may not properly operate if you fail to do so. No Medical Advice

You acknowledge and agree that neither the App nor any of the Services offers medical advice. HealthOK, its licensors and service providers are not responsible for the accuracy, timeliness, or completeness of your Personal Information, or for any reliance by you or any medical professional on your Personal Information within the App, if any. HealthOK is not responsible for any health care provider's reliance or non-reliance on your account or any other reports, materials or data (including any Personal Information) generated or otherwise made available by or through the App (including any use thereof) or through any use of the Services, or the accuracy thereof. **Please consult your doctor before performing any tasks or activities based on information provided or made available to you through the App. Please consult your doctor before taking any supplements or drugs based on information contained in your App or any other reports or information provided or made available to you through the App.**

By downloading, accessing or using the App, you expressly acknowledge and agree that:

- The App is not intended to be a replacement for medical consultations from your doctor; and

- The App is intended to be used only as a tracker for the care, including medical care, of relatives or dependents in India ("Dependents").

9. Risks and Considerations Regarding the Services

- You understand that by providing any test data, having Medical Information processed, accessing Medical Information, or providing Self-Reported Information, you acquire no right, title or interest in or to any research, products or services that may be developed by or through HealthOK, its affiliates or any of their respective collaborating partners. You specifically understand and agree that you will not receive compensation for any research or commercial products that include or result from Medical Information or Self-Reported Information.
- You have the authority and capacity, under the laws of the state or jurisdiction in which you reside, to make the representations and be bound by the covenants provided in this Section.

12. Services Offered by Third Parties

We may offer you the opportunity to purchase products or services from companies other than HealthOK. Use of those services will be subject to the terms and conditions of the companies offering the applicable products or services. Please read those terms carefully. You expressly acknowledge and agree that we make no representations or

warranties, express or implied, with respect to such third-party products or services and we have no responsibility or liability whatsoever with respect to such third-party products or services.

Your correspondence or business dealings with or participation in promotions of information providers, vendors, and/or resources found on or through the Services, including payment and delivery of related goods or services, and any other terms, conditions, warranties, or representations associated with such dealings, are solely between you and such information provider or resource. You acknowledge and agree that HealthOK shall not be responsible or liable for any loss or damage of any sort incurred as the result of any such dealings or as the result of the presence of such information provider or resources on the Service.

In any dispute, NEITHER YOU NOR WE WILL BE ENTITLED TO JOIN OR CONSOLIDATE CLAIMS BY OR AGAINST OTHER USERS IN COURT OR IN ARBITRATION OR OTHERWISE PARTICIPATE IN ANY CLAIM AS A CLASS REPRESENTATIVE, CLASS MEMBER, OR IN A PRIVATE ATTORNEY GENERAL CAPACITY. The arbitral tribunal may not consolidate more than one (1) person's claims, and may not otherwise preside over any form of a representative or class proceeding.
